Introduction

Solution

Integrated Solution

Reaching beyond access control, AC2000 provides The Council with a host of features which can be used to enhance operations and eliminate the need for multiple systems.

The system at Al Bahar Towers utilises the powerful AC2000 AED (Alarm Event Display) which provides a real time graphical representation of events and alarms occurring throughout the system. AC2000 AED provides a single user-friendly interface from which operators can acknowledge and cancel alarms, record comments on system activity, report on alarms and more.

The Council also opted for integrated ID Badging using AC2000 VIPPS (Visual Imaging & Pass Production System). AC2000 VIPPS allows Council administrators to produce professional quality permanent and temporary ID passes. Images can also be exported from AC2000 VIPPS to external systems such as HR systems

High Redundancy

The Council required the highest levels of system redundancy, with the assurance that the access control system would not fail, even if the main server fails. AC2000 Failover has been used at Al Bahar Towers to create and maintain a copy of the main AC2000 server. In the event that the main server fails, the AC2000 Failover server will immediately take over until such times as the main server is restored, meaning that the access control system can continue to operate as normal.

Custom 'VIP' Lift Interface

CEM developed a custom lift control interface for the Council allowing identification and special access for VIP users requesting lift call. Lift cars are then assigned to VIPs on a priority basis.

Industry Leading Hardware

AC2000 is supported at Al Bahar Towers by CEM's industry leading hardware. The installation utilises the S610s card reader which offers intelligence at the door with an offline database for card validation even when communication with the host server is temporarily unavailable.

The S610s offers an excellent user experience with an LCD providing information on card swipes, such as CARD EXPIRING and ACCESS GRANTED. The keypad on the reader also provides the possibility of dual layer validation using card and PIN.

CEM's DCM 300 Door Control Module was also deployed at the site, allowing 3rd party readers to be interfaced to AC2000.
